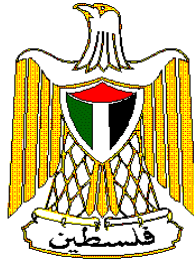

Executive Summary

In a recent study may be considered the first of its kind in the official statistical level in the Arab world, is pleased to Central Bureau of Statistics Palestinian view the main findings of the survey provision, which was implemented in the period 16/10/2008 - 30/11/2008 a sample amounted to 2,544 families divided by 1,764 Households in the West Bank and 780 Households in the Gaza Strip.

Data showed that 17.0% of the Palestinian Territory households' members experienced Dispute during the last five years; however, only 10.5% of them (including 12.6% for the West Bank and 6.4% for Gaza Strip) referred to the court for arbitration. Additionally, most of the lawsuits in the Palestinian courts (79.2%) were criminal ones, including theft, fight, homicide or assault.

Moreover, the survey findings showed that 86.0% of individuals in the Palestinian Territory; (86.8% in the West Bank and 83.9% in Gaza Strip) believed that Palestinian judges were independent in making decisions. They had come to this conclusion through personal experience with courts. Additionally, 42.0% of the individuals said that they would go to Palestinian courts if they had a Dispute that required judicial intervention; 39.9% said they would refer to clannish arbitration; and 18.1% said they would seek other types of arbitration.

Survey findings showed that 45.0% of the individuals in the Palestinian Territory believed that the freedom of demonstration and peaceful assembly did not exist, 27.8% stated that the freedom of thought and belief did not exist, and 35.4% (28.3% in the West Bank and 49.0% in Gaza Strip) stated that there was no freedom of press and media in the Palestinian Territory.

The study showed that 66.3% of the interviewed individuals believed that men and women had equal opportunities to reach senior positions at the different institutions, 50.5% of the Persons believed that the women's achievements in the society were sufficient, and 53.2% stated that the adopted laws in the Palestinian Territory did not discriminate between men and women while 42.3% thought they did. 94.0% of the interviewed individuals rejected violence against women in any case.

Data revealed that, 63.4% of the interviewed individuals in the Palestinian Territory stated that the official Palestinian performance in creating better socioeconomic conditions was inadequate; Moreover, 52.8% of the Palestinian Territory population assessed the official Palestinian performance in fighting corruption as good.

Data revealed that, 97.3% of the Palestinians in the Palestinian Territory agreed that NGOs played effective role in the society and 95.7% of them agreed that NGOs' programs were based on society's needs. Furthermore, 68.3% stated that NGOs played a role in monitoring policies and laws.

Governance survey revealed that there was a gap between individuals satisfaction with teaching methods and curriculum. Such gap was expressed in the fact that 44.6% of the individuals expressed satisfaction with teaching methods and curriculum of the public schools compared to 68.5% who were in favor of teaching methods and curriculum of the private one and 54.9% who were in favor of UNRWA-operated

schools. Furthermore, 80.0% of the respondents were satisfied with the environment of the public schools and in terms of location and equipment compared to 88.0% who were satisfied with the private schools and 91.2% who were satisfied with the those of the UNRWA-operated schools. 86.9% of the Persons said that they were satisfied with the teachers' competency in the private schools compared to 79.9% and 55.5% who were satisfied with the Teachers' competency at UNRWA-operated schools and government schools, respectively. 85.1% were satisfied with the competencies of the teachers at the higher education institutions.

Findings revealed that, 88.1% of the persons said that cleanliness at medical centers and hospitals was good and 83.2% said that the competencies of the doctors of the Palestinian Territory were good; however, 26.0% of the individuals said that the availability of appropriate medical equipment was inadequate.

Data showed obvious variation between individuals satisfaction with their wages. In Gaza Strip, 74.2% of them said they were satisfied with their wages compared to 43.3% in the West Bank. Moreover, 51.9% of the individuals in West Bank said they felt secure at their jobs compared to 44.1% in Gaza Strip.

The main reason for the increase in unemployment rates in the Palestinian Territory was referred to the Israeli siege and occupation, according to 94.1% of the individuals in the Palestinian Territory while 86.1% referred it to inefficient private sector and 85.7% to incorrect government policies.

Chapter One

Definitions and Concepts

Clannish Arbitration:

This is the unofficial way of solving conflicts among citizens outside the framework of the regular courts. Clannish arbitration draws its provisions from the dominant clannish traditions of the area where it functions. Such traditions are drawn from the Arab Palestinian historic, social, and cultural legacy. This arbitration is conducted by individuals belonging to different families and clans of various social backgrounds.

Corruption:

To break a law or the regulations based on such law or to violate the general policies approved by the public servant for own or other people benefits or to consciously abuse the absence of the law for such benefits.

Dispute:

It is a conflict between two parties who could be individuals or groups or institutions. The conflict could be the result of conflicting interests or infringements upon rights or freedoms. The conflict could also be due to an infringement on behalf of an individual, institution, or group of people of the effective laws of the Palestinian Territory.

Executive Authority:

The president, the ministers, and the directorates of the state. Their main responsibilities include executing the laws and legislations of the judicial authority.

Governance:

Governance expresses the practice of a political authority, and the administration of such authority of the society's affairs and resources as well as its socioeconomic development. Governance is a larger concept compared with government since it embodies the operations of the unofficial institutions, the civil society organizations, and the private sector in addition to the operations of the official state agencies including the executive, legislative, and judicial authorities as well as the public administration. The concept of governance also reflects the political, economic, and social practices of the authorities in running public affairs at all centralized and decentralized levels, i.e. the national, regional, and local levels.

Independence:

It is the capacity of a governmental or non-governmental institution that is working for the benefit of the public, to take its work-related decisions in accordance with the effective laws and the interests of the work without intervention of an external party whether such party is governmental or non-governmental, group, or individual.

Judicial Authority:

It is the authority that is represented in all types of courts, which adjudicates all kinds of conflicts between the individuals of the society or between the citizens and the government in accordance with the state's constitution and laws.

Lawsuit:

It is when a person (plaintiff) seeks to obtain what he/ she believes is his/ her right from another person or people (defendant(s)) in the presence of a judge.

Legislative Authority:

Legislative authority is also known as the parliament, the legislative council, the people's council, the house of representatives, the congress, the council of the national society, or any other name. The legislative authority is the authority that passes the laws in line with the conditions and needs of the society.

Rule of law:

The rule of law is to consider the law as the reference to all and to be above all with no exceptions. This, necessarily, requires establishing and developing a stable governance form through political stability, civil peace, and building of democratic institutions, which allow peaceful and periodic transition of power without resorting to violence.

Household:

The household is defined as one person or a group of persons with or without a family relationship, who live in the same housing unit or part of the housing unit, share meals and make joint provision of food and other essentials of living.

Household Membership:

Persons staying in the dwelling unit are considered members of the household if the dwelling unit is their usual or only place of residence.

Unemployed:

Unemployed persons are those individuals aged 15 years and over who did not work at all during the reference period, who were not absent from a job, were available for work and actively seeking a job during the reference period by one of the following methods news paper, registered at employment office, ask friends or relatives or any other method.

public Sector:

Includes all institutions of the three branches of legislative, judicial and executive.

private Sector:

Includes all institutions owned by individual/s or almost belongs to profit institutions.

Curriculum:

The strategic plans which lead the education policies in the schools which targeted particular class with its suitable contents to be accumulative in the educational environment.

local Authority:

The body which authorized to supervise providing the public services and the population whole affairs on the community level

Chapter Two

The Methodology

This chapter presents the scientific methodology that was adopted in the planning and implementation of the Democratic Governance survey in the Palestinian Territory in 2008, including the methodology design of basic research instruments and methods of collection, processing and analysis of the survey's data.

2.1 Survey questionnaire:

The survey questionnaire on Democratic Governance is the main instrument for data collection, and thus its design took into consideration the standard technical specifications to facilitate the collection, processing and analysis of data. Because this type of specialized surveys is new to PCBS, relevant experiences of other countries and international best practices were thoroughly reviewed to ensure the contents and design of the survey's instruments are within international standards. The survey's questionnaire includes the following basic components:

Identification data:

The identification data constitutes the key that uniquely identifies each questionnaire. The key consists of the questionnaire's serial number, locality code, and governorate code. The classification of localities is according to the Standard Administrative Classification that was adopted by a national committee composed of representatives of various national institutions, and applied by PCBS in the Population, Housing and Establishment Censuses 2007.

Data quality control:

A set of quality controls were developed and incorporated into the different phases of the survey including field operations, office editing, office coding, data processing, and survey documentation.

Survey's main indicators:

The first section of the questionnaire includes identification data about the geographical location and the population. Other sections include data about: the rule of law, the right to access public office, election, the performance of the Palestinian Legislative Council (PLC), government and civil institutions, freedom of opinion and expression, the press and the right to information, freedom to affiliate with and form political parties, the right to education, health, employment and housing.

2.2 Sample and sampling frame

Target population

All Palestinian individuals aged 18 years and over whose usual place of residence with their households was in the Palestinian Territory in year 2007.

The sampling frame

The sampling frame consists of enumeration areas adopted in the Population, Housing and Establishment census 2007. Each enumeration area has an average size of about 120-150 households.

Sample size

The sample size of the survey was estimated to about 2,544 household.

Sample design

The sample is stratified clustered systematic random sample. The design is comprised of three phases:

1. Random sample of 212 enumeration areas
2. Selection of (12) household from each enumeration area, selected in phase one, using systematic random manner
3. Selection of a person (aged 18 years or more) in the field from the selected households; and KISH TABLES were used in the selection of persons (alternating one male and the next female) to ensure indiscriminate selection.

Sample strata

Distribution of the sample was stratified by areas (North of West Bank, South of West Bank, Middle of West Bank, and Gaza Strip), and type of locality (urban, rural, camps).

2.3 Fieldwork operations

The purpose of fieldwork operation is to collect the required data from its primary sources, and considered the most important stage in the implementation of any survey. As a result, greater attention was given to the details of the fieldwork operations of the Democratic Governance survey to ensure the implementation is within the standards. These details included all of technical and administrative requirements, fieldwork procedures, recruitment procedures, training of fieldworkers, and provision of necessary physical requirements to successfully implement the survey.

Fieldwork procedures

Fieldworkers were instructed to work according to the following instructions:

1. Locate the beginning of the enumeration area using either the relevant guide or the map (if available)
2. Turn right and walk clockwise within the enumeration area
3. List adjacent households until the completion of twelve households
4. Do not allocate questionnaires for households or individuals who refuse to respond to or who were not available during the visit of the fieldworker.
5. Use of the Kish Tables for selection of a person randomly from the list of household members.
6. Select male member from those households with odd number in the enumeration area, and female member from households with even numbers.

Training and selection of fieldworkers

Qualified fieldworkers with previous experience in statistical data collection were selected to work in the data collection of the survey. Fieldworkers participated in

specialized fieldwork training in which the details of the survey's questionnaires were explained thoroughly along with practical exercises to ensure clarity.

A special attention was given on the uniqueness of the survey of Democratic Governance, including the questions, terminology, and concepts. The training program of fieldworkers included:

1. Introduction to the Democratic Governance survey and its objectives
2. Explanation of used terminology
3. Procedures for data collection using the designated questionnaire

Distribution of the field work team:

The fieldwork team consisted of fieldwork coordinator, supervisors and fieldworkers. Every five fieldworkers were supervised by one supervisor. Fieldwork offices were used to facilitate the administration of fieldwork activities including the distribution and delivery of questionnaires, fieldwork editing during data collection, and preparation as well as submission of daily progress reports.

Fieldwork activities had started on 16/10/2008 till 30/11/2008. The sample of the survey had reached 2,544 household distributed to 1,764 household in the West Bank and 780 household in the Gaza Strip. Interviews were conducted with either the head of the household or with other qualified member. Fieldworkers were provided with all necessary requirements (i.e. questionnaires, sample list).

During fieldwork activities, 2,544 households in the West Bank and Gaza Strip had been interviewed. The results of these interviews were as follows:

- 1 Completed: 2,517 questionnaire
- 2 Partially completed: 11 questionnaire
- 3 Total: 2,544 questionnaire

2.4 Data processing

Data processing phase includes many interdependent activities that aim to electronically capture the collected data to be ready for analysis. These activities are:

- 1 Office editing: Questionnaires were reviewed according to rules specified in special editing manual specifically designed for the survey. The purpose of this activity was to ensure that the questionnaires had no consistency errors, and no uncompleted questionnaires.
- 2 Programming and data entry stage: This stage included preparation of the data entry programs, setting up the data entry control rules to avoid data entry errors, and validation queries to examine the data after its being electronically captured.
