Preface

The Palestinian tourism sector has great potential and is expected to occupy a large share of the Palestinian GDP once the tourist resources are well exploited. Tourism activities are, however, crippled by a multiplicity of internal and external factors, which are not enabling this important economic activity to flourish.

PCBS has implemented several surveys to cover the supply and demand sides of tourism, including the Hotel Activity survey in the Palestinian Territory (a continuous and permanent survey since 1996), a survey of Tourism Activities 2002, 2007 and 2009, and the Domestic Tourism survey for the years 1998, 2005, 2006, 2008 and 2009. In addition, PCBS has implemented additional related surveys including the survey of Outbound Tourism in 2004, a survey of Inbound Tourism in 2005, a survey of Inbound Visitors in 2009 and a survey of Hotel Guests in 2008, 2009. These statistical activities cover an important aspect of tourist-related statistics and are important to build the necessary database to establish the Tourism Satellite Accounts (TSA) in the Palestinian Territory.

This report addresses the main indicators of the hotel industry. These indicators include the number of operating hotels, number of rooms and beds, public facilities in the surveyed hotels, number of employed persons in hotels, number of guest nights in the reference period, number of guests by nationality and rates of bed and room occupancy.

PCBS is pleased to present the Third quarter of the year 2010 on “Hotel Activities in the Palestinian Territory” as an important statistical reference on hotel activities. PCBS hopes that this bulletin will pave the way for developing a comprehensive tourist program to meet users needs and international standards.

Executive Summary

The main findings of the Hotel Activities Survey during the third quarter of 2010 are as follows:

- There were 94 operating hotels in September 2010, offering 4,811 rooms with 10,252 total available beds.
- The average occupancy of rooms in the Palestinian hotels was 1,700.1.
- The percentage of rooms occupancy was 35.2%; and it increased by 2.6% compared with the previous quarter.
- The average number of workers in the hotels was 1,783 of whom 259 were females.
- The total number of guests in the Palestinian hotels was 137,733 persons of whom 11.1% were Palestinian guests and 35.1% were from the European Union countries.
- The number of guests showed a decrease of 1.7% compared with the previous quarter.
- The total number of guest nights was 304,504. The number reflects a decreasing by 4.6% during the third quarter 2010 compared with the previous quarter, and 2.0% compared with the corresponding quarter in the year 2009.
- Most of the guests nights were in Jerusalem and the south of the West Bank, representing 42.1% of the guests were in Jerusalem, whereas 37.6% of the total guests in the south of the West Bank hotels.
- The average length of stay in Palestinian hotels was 2.2 nights per guest during the third quarter 2010.

Chapter One

Introduction

Tourism is considered a cornerstone of the Palestinian economy and there are many attractive touristic resorts for people of different interests. PCBS began to collect statistical data on tourism and monitor hotel activities through a continuous and comprehensive monthly survey since 1996, in accordance with the recommendations of the World Tourism Organization and European Union. The survey aims to produce a comprehensive database and time series of basic indicators on the hotel industry to enable the development and promotion of the tourism industry in the Palestinian Territory.

A quarterly report is regularly produced in addition to annual consolidated report . This publication presents data on hotels for the first quarter 2010; and results indicate an improvement in most indicators compared with the corresponding quarter since 2001, while it reflects a decrease in most indicators compared with the fourth quarter 2009.

Chapter Two

Concepts and Definitions

This section presents the main concepts and definitions used to derive the main indicators of tourism statistics. These concepts and definitions are based on international recommendations in the field of tourism statistics, and are applied to the rest of the common subjects in the PCBS. The main concepts and definitions mentioned in this report were as follows:

Hotel:

It is defined as an accommodation establishment providing overnight lodging for the visitors in a room or unit. It should hold a number of persons exceeding that of an average single family. The establishment must be under one management, and provides various facilities and services to visitors.

Operating Hotels:

It is defined as the hotels that included in the sample frame and results, excluding the non operating hotels that are carrying out repairs or maintenance, and the hotels which didn't respond to the survey.

Number of Rooms:

It refers to the furnished rooms for the use of guests. Such rooms might be single, double, triple, or quadruple. Rooms involving more than four beds were classified under (others) in the questionnaire. As for the suite, it is usually comprised of one bedroom or more, a living room and private toilet facilities.

Available Beds and Rooms:

It refers to beds and rooms which are ready for use during the reference period. Rooms closed for maintenance or repairs are excluded.

Guests:

It refers to visitors staying in the hotels and using their facilities. Records of new guests are based on the number of visits regardless whether it's the same person or different.

Number of Guest Nights (Bed Occupancy):

Number of beds booked for hotel guests. Such beds are considered as occupied whether they were actually used or not. It is measured by guest night unit.

Room Occupancy:

Number of booked and paid rooms. Such rooms are considered occupied whether they were actually used or not.

Average (rooms, beds) Occupancy:

It is defined as the total number of occupied (rooms, beds) divided by the number of days.

Percentage of (rooms, beds) Occupancy:

It is defined as the average of (rooms, beds) occupancy divided by available (rooms, beds) multiplied by one hundred.

Average Length of Stay:

Represents the total of guest nights by nationality divided by number of guests of the same nationality.

North of West Bank Region:

Jenin, Tulkarm, Nablus, Qalqiliya, Salfit and Tubas governorates.

Middle of West Bank Region:

Ramallah and Al-Bireh, Jericho and Al-Aghwar governorates.

Jerusalem Region:

Jerusalem governorate.

South of West Bank Region:

Bethlehem and Hebron governorates.

Gaza Strip:

North Gaza, Gaza, Deir Al-Balah, Khan Yunis and Rafah governorates.

Chapter Three

Main Findings

The main findings of the Hotel Activities Survey during the first quarter of 2010, show that there were 95 operating hotels in March 2010 offering 4,898 rooms with 10,520 total available beds.

3.1 Hotel Capacity during March, 2010

The operating hotels within the Palestinian Territory in the first quarter 2010 were distributed as follows:

- North of West Bank: 7 hotels including 166 rooms comprising 363 beds.
- Middle of West Bank: 25 hotels including 1,062 rooms comprising 2,369 beds.
- Jerusalem Region: 30 hotels including 1,467 rooms comprising 3,195 beds.
- South of West Bank: 25 hotels including 1,882 rooms comprising 4,057 beds.
- Gaza Strip: 8 hotels including 321 rooms comprising 536 beds.

3.2 Room Occupancy during the First Quarter, 2010

The average occupancy of rooms in the Palestinian hotels was 1,554.1 representing 31.0% from the available rooms.

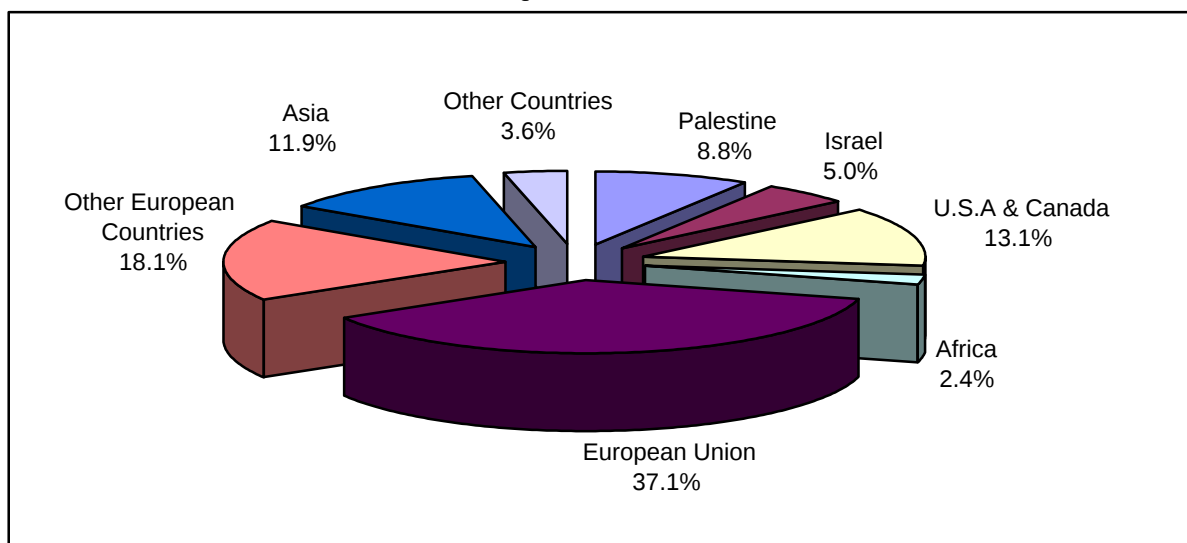
3.3 Hotel Workers during the First Quarter, 2010

The average number of workers in the hotels was 1,802 of whom 1,548 were males and 254 were females. The number of workers in hotel's administration was 327 of whom 264 were males and 63 were females. There were 1,475 workers in hotels services of whom 1,284 were males and 191 were females.

3.4 Guests and Nights Occupancy during the First Quarter, 2010

The total number of guests in the Palestinian hotels was 124,205 persons of whom 8.8% were Palestinian guests, and 37.1% were from the European Union countries. The number of guests showed an increase of 79.1% compared with the same quarter of the year 2009.

The total number of guest nights in Palestinian hotels during the first quarter 2010 was 285,879 of which: 8.9% of these nights were occupied by Palestinian guests, 38.5% by guests from European Union countries, and 12.7% by guests from the United States and Canada.

The guest nights distributed according to region are as follows: guests spent 41.0% of total nights in Jerusalem hotels, and 17.9%, 39.7%, and 1.3% in Middle, South, and North of the West Bank, respectively; while 0.1% of nights in Gaza Strip hotels.

The table below presents the main results of the first quarter of 2010, and explains the changes that occurred in the main indicators for Palestinian hotels activities compared with the previous quarter and with the results of the first quarter of 2009.
